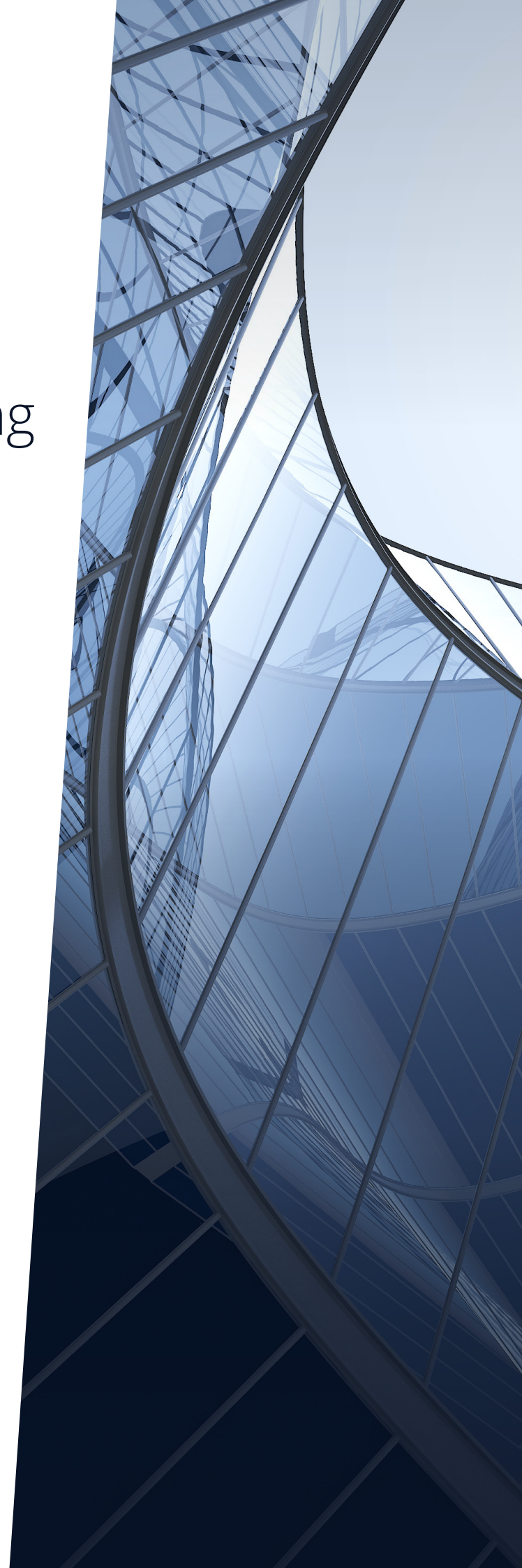

- provide strategic advice in relation to the preservation of assets for enforcement (including as to whether any interim conservatory measures may be required and in which jurisdictions such measures may effectively be sought);
- advise on measures required to ensure that the award or judgment, once rendered, will be enforceable in the jurisdictions where assets are located;
- formulate a heavy-hitting multi-jurisdictional enforcement strategy ready for deployment if the award or judgment is ultimately not paid voluntarily.

Bespoke solutions for your organisation

When you expect that your counterparty will not voluntarily satisfy your award or judgment, bringing Omni Bridgeway on board from the outset – even when you don't seek Omni Bridgeway's funding to meet the costs of the proceedings – will maximise your chances of recovery.

Successful identification and monitoring of assets to lay the foundation for successful recovery requires integrated intelligence, strategy and timing. The earlier you bring experts onboard the better.

We assist clients during their dispute resolution journey to identify assets and prevent their dissipation to maximise recoveries.

We understand that clients do not always wish to utilise Omni Bridgeway's capital to fund the substantive proceedings. The benefits of our global enforcement expertise and strategic insight are however still available.

Omni Bridgeway's asset monitoring and enforcement funding solution is available for clients who foresee enforcement risk and either (i) wish to fund the merits phase themselves, or (ii) the uncertainties of the case mean our investment criteria for the funding of the merits phase are not able to be satisfied. The asset monitoring and enforcement funding agreement is entered into during the merits phase of the proceedings, with the nature of Omni Bridgeway's services converting from asset identification and preservation to enforcement once the judgment or award is finalised and the debtor refuses to pay.

The funding structure operates as follows:

01 During the merits phase:

- The asset monitoring and enforcement funding agreement is executed;
- A lower success fee, payable only from recoveries in the proceedings, is applicable;
- The client continues to pay all legal fees and expenses of the ongoing case; and
- Omni Bridgeway:
 - Will conduct a global asset trace to identify assets of the counterparty(ies);
 - Regularly monitors the counterparties' assets;
 - Provides strategic advice in relation to the preservation of assets for enforcement, in particular (i) whether interim measures to preserve assets may be required and whether, where and how that can be achieved; and (ii) to ensure that the final award will be enforceable (including, amongst others, by advising on the counterparties that should be included as parties to the claim and checking the validity of the relief requested); and
 - If assets are located in jurisdictions where pre-judgment attachments are allowed (and third-party funding of proceedings to obtain such pre-judgment attachments is permissible), fund these actions.

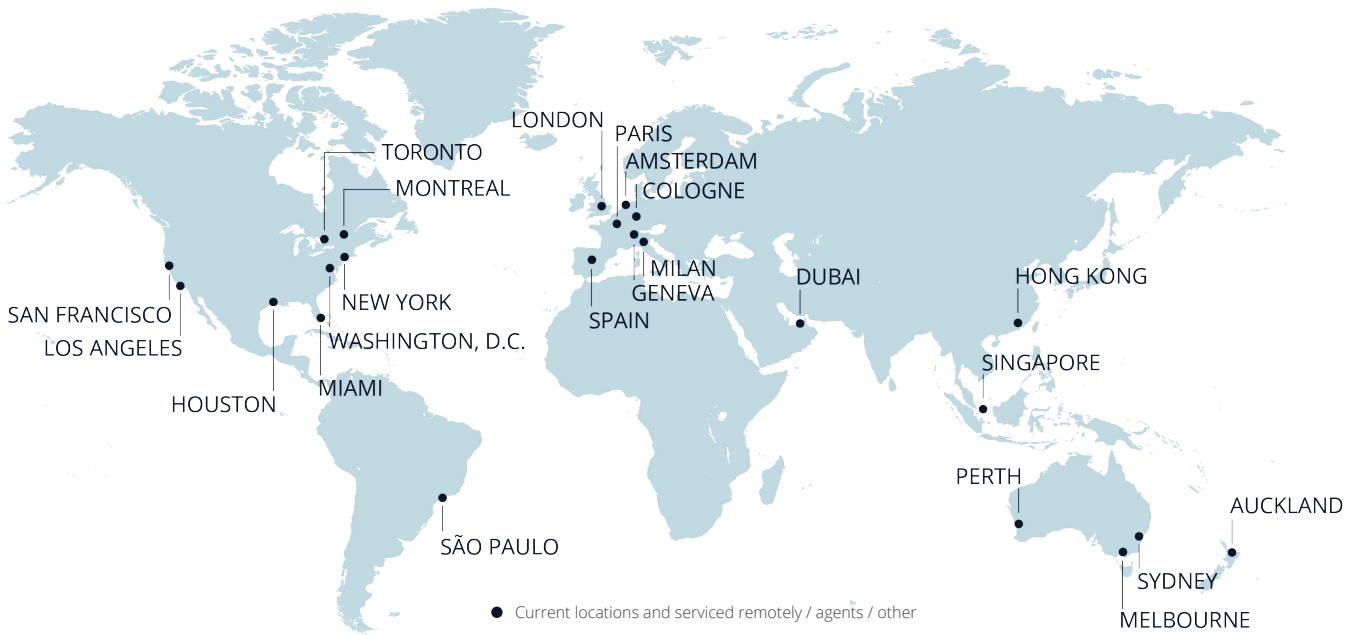
02 Post award:

- A higher success fee will be applicable once the merits phase has concluded; liability is established and the debtor does not voluntarily pay the award or judgment;
- Omni Bridgeway will refine its coordinated global enforcement strategy on the basis of its up-to-date understanding of the debtor's asset position; and
- Omni Bridgeway will assume the risk of funding the recovery and will manage the enforcement strategy with regular reporting to the client.

All funding provided by Omni Bridgeway is non-recourse, meaning we are only paid if the case is successful, with success determined by the receipt of funds and not just the issuance of a positive award or judgment. On a successful resolution, Omni Bridgeway is typically entitled to reimbursement of the amounts it has paid plus a fee, calculated as a percentage of the resolution sum or a multiple of the amount invested. The amount of the fee depends on the case and its duration. The fee is lower if the case resolves sooner.
