# Funding for Claimants and Counsel

## CLAIMANTS

### Affording expensive legal fees

Claimants use our funding to cover legal fees for a single arbitration or portfolios containing multiple arbitration matters or a mix of commercial litigation and arbitration matters. Tapping outside capital from Omni Bridgeway allows our clients to engage in business as usual throughout the lengthy arbitration process without being financially burdened with the expense of pursuing their claims.

### Enforcing Awards

Omni Bridgeway also helps claimants collect on hard-won arbitration awards. Our team offers unmatched asset tracing and recovery experience, providing the assistance claimants need to prepare for and overcome the final obstacle in their dispute resolution journeys.

### Sharing Risk with Clients

For counsel representing Omni Bridgeway-funded claimants, we provide a vehicle for sharing risk with clients without assuming debt or compromising the quality of the representation. Our funding allows a firm to be paid a portion of its fees throughout each matter, plus retain the potential of upside when the client prevails in the arbitration.

### Monetizing Portfolios of Claims

We also provide non-recourse funding directly to either claimants or law firms seeking to monetize portfolios of three or more arbitration claims, or a combination of affirmative arbitration and commercial litigation claims. Claimants often use our portfolio funding to finance claims across their business units. Law firms use it to offer flexible fee arrangements and to provide competitive prices to clients while mitigating risk.

- 2 Security for costs and adverse cost awards
- 3 Monetization of arbitration assets for business purposes
- 4 Working capital
- 5 Preservation of resources
- 6 Removal of the cost of arbitration from the income statement
- 7 Award enforcement proceedings
- 8 Award execution/monetization



## Investment considerations

- Qualifications and arbitration-specific experience of counsel
- Documentary and witness evidence on factual issues

- Security for costs
- Adverse costs awards
