Notice under Section 708A(5)(R)(E) of the Corporations Act

On 25 August 2020, Omni Bridgeway issued 3,604,207 ordinary shares pursuant to Omni Bridgeway's Long Term Incentive Plan (**Plan**) following the satisfaction of the vesting conditions applicable to the performance rights issued in respect of FY18.

Omni Bridgeway advises that the Corporations Act 2001 (Cth) (**Act**) restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or section 708A. By Omni Bridgeway giving this notice, a sale of the shares noted above will fall within the exemption in section 708A(5) of the Act.

Omni Bridgeway hereby notifies ASX under paragraph 708A(5)(e) of the Act that:

- 1. Omni Bridgeway issued the securities without disclosure to investors under Part 6D.2 of the Act;
- as at the date of this notice, Omni Bridgeway has complied with the provisions of Chapter
 2M of the Act as they apply to Omni Bridgeway, and section 674 of the Act; and
- 3. as at the date of this notice, there is no information that is excluded information under section 708A(7) and (8) of the Act that has not already been disclosed to investors generally.
